1 WELCOME TO ALL- the Chair

2 INTRODUCTIONS and APOLOGIES: Amanda Crossfield would talk about Climate Change as it was affecting Yorkshire Water's programme. Apologies from Alison Sinclair, Tom Waring, June Tranmer, John Bibby, Mick Phythian, Audrey Miller Denise Craghill

3- CLIMATE CHANGE and FUTURE WATER SUPPLY- Amanda Crossfield

AC reminded members of the floods in 2007,2012 and 2015 and their significant impacts on York city in particular, It was predicted that flooding events might become more variable in timing and more extreme in severity. The Yorkshire Water upland catchment area covered some 29,000 ha, in addition to the underground supplies, largely in East Yorks, which needed careful extraction management if they were not to be depleted at an unacceptable rate. A major issue to be considered was population growth in the area, where it was likely to be concentrated, and changes in lifestyle resulting from increased public awareness of the need to conserve water. Plans were presented showing the piped water supply grid which allows for redirection of supply across the region. Details of management of upland areas were tabled, to slow the flow downstream and conserve peat deposits and natural habitats, while allowing for legitimate commercial interests to continue. There were sometimes conflicts in this area. The company was working to a 25 year plan, which would be updated every five years, with a significant emphasis on leakage prevention. This attempts to identify known risks, and channel investment accordingly. An encouraging message was that the company was well placed to ensure continuity of supply across the region, in the light of the current information available.

Members thanked Amanda for her optimistic presentation, with the caveat that unless consumers played their part in reducing consumption restrictions on use might be a distinct possibility.

4- THE YEF WEBSITE - THE WAY FORWARD - Mike Bonsali

MB illustrated various approaches to web-site design, from the generalised to the highly selective. The YEF must decide what its audience is likely to be, its demographic, how much information it could easily absorb over what timeframe. It must avoid information overload and feature selected links rather than repeat information. Should it complement posts on Facebook? Who would edit and manage the content? Members noted that outstanding graphic design, simplicity in use, highly legible text and good colour contrast were essential to project a professional image. What does the YEF expect to get out of this? Will it be self-referential? It needs to take forward a clear message, otherwise it could seen to be "all things to all men", with no coherent focus.

Members thanked Mike, who agreed to refine his ideas for further discusion.
